

2. The Assignor agrees to perform all reasonable and proper additional acts and to execute any additional documents at the request of the Assignee which may be required to transfer all of the Assignor's rights, title and interest in and to the said Marks and/or the rights thereto to the Assignee, its successors and assigns.

3. Assignor acknowledges and agrees that it has the power and authority to assign the Marks to the Assignee.
