THIS ASSIGNMENT is made the 10th day of November 2008

BETWEEN:

- (1) **Komodo Limited** (Company No: 02895688) whose registered office is at 18 Hyde Gardens, Eastbourne, East Sussex, BN21 4PT ('the Assignor') and
- (2) **The Yakit Rakit Limited** (Company No: 02068873) whose registered office is at 51 Mornington Road, Chingford, London, E4 7DT ('the Assignee')

NOW IT IS AGREED as follows:

1. Definitions

In this Assignment the following term shall have the following meaning:

'Trade Marks' means the registered Community Trade Mark number 002311769 registered in Class 25 dated 17 January 2006 and the registered USA Trade Mark number 3021318 registered in Class 25 dated 29 November 2005.

2. Recitals

The Assignor is the registered proprietor of the Trade Marks and has agreed to assign them to the Assignee on the terms and conditions set out below.

3. Assignment & Claims

- 3.1 In consideration of the sum of £1 (one pound) now paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges) the Assignor with full title guarantee assigns the Trade Marks to the Assignee absolutely together with all the Assignor's rights and interests in respect of them including (but not limited to) any common law rights, all the goodwill attaching to the Trade Marks and any claims associated with the Trade Marks (whether currently known about or not).
- 3.2 This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trade Marks (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks), together with the right to demand sue for recover receive and give receipts for all amounts due under or in relation to claims or proceedings in respect of the Trade Marks together with the benefit of all causes of action in relation to the Trade Marks together also with the benefit of all covenants and undertakings from third parties in relation to the Trade Marks and together with any other right title or interest of the Assignor in relation to the Trade Marks.

4. Registration of new proprietorship

The Assignor agrees with the Assignee at the direction and expense of the Assignee to execute any further document that the Assignee may reasonably require to enable the Assignee to become registered by the Registrar of Trade Marks and the US Patent and Trade Mark Office as the proprietor of the Trade Marks.

5. Assignor's warranties and indemnity

The Assignor warrants that:

- 5.1 The Assignor is the proprietor of the Trade Marks and has full power to enter into this Assignment.
- 5.2 The Assignor has not granted any assignments by way of security, charges or licences to use the Trade Marks.
- 5.3 The Assignor has not either by act or omission caused or permitted anything which may endanger the registration of the Trade Marks.
- 5.4 The Assignor has not knowingly withheld from the Assignee knowledge of any circumstance that may cause the Registrar of Trade Marks to object to the registration of this Assignment.
- 5.5 The Assignor will keep the Assignee indemnified against all actions claims proceedings costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisors to compromise or settle any claim) and all legal costs or other expenses arising out of any breach of the above warranties or out of any claim by a third party based on any facts which if substantiated would constitute such a breach.

6. Joint and several

All agreements on the part of either of the parties which comprises more than one person or entity shall be joint and several.

7. Proper law and jurisdiction

This Assignment shall be governed by the law of England and Wales in every particular including formation and interpretation and shall be deemed to have been made in England and Wales and both parties agree to submit to the jurisdiction of the courts of England and Wales.


8. VAT


