## PATENT AND TRADEMARK SECURITY AGREEMENT

This Patent and Trademark Security Agreement (this "**Agreement**"), dated as of November 20, 2008, is entered into by and among ROTONICS MANUFACTURING INC., a Delaware corporation ("**Rotonics**"), STRATIS CORPORATION, a Wisconsin corporation ("**Stratis**", together with Rotonics, the "**Debtors**" and each a "**Debtor**"), and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, as administrative agent (in such capacity, the "**Secured Party**") for the Lenders, as defined in the Credit Agreement described below.

Rotonics, the Secured Party and various Lenders are parties to a Term Loan Agreement dated as of February 23, 2007, as amended by a First Amendment to Term Loan Agreement and Waiver of Default dated as of August 23, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), pursuant to which the Lenders have agreed to make advances and extend certain other financial accommodations to Rotonics. All capitalized terms used in these Recitals and not otherwise defined herein shall have the respective meanings set forth in the Credit Agreement.

Rotonics and the Secured Party, as administrative agent for the Lenders, are parties to a Security Agreement dated as of January 26, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Rotonics Security Agreement**"), pursuant to which Rotonics has granted the Secured Party a security interest in substantially all of the personal property of Rotonics, including the Patents and Trademarks (as defined in the Rotonics Security Agreement) of Rotonics. Rotonics and the Secured Party, as administrative agent for the Lenders, are parties to a Patent and Trademark Security Agreement dated as of January 26, 2007 (together with all amendments, modifications and restatements of such agreement the "**Rotonics Prior Patent and Trademark Security Agreement**"), pursuant to which Rotonics confirmed that it granted a security interest in its Patents and Trademarks to the Secured Party to secure payment of the Obligations.

Stratis and the Secured Party, as administrative agent for the Lenders, are parties to a Security Agreement dated as of August 23, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Stratis Security Agreement**", together with the Rotonics Security Agreement, the "**Senior Security Agreements**"), pursuant to which Stratis has granted the Secured Party a security interest in substantially all of the personal property of Stratis, including the Patents and Trademarks (as defined in the Stratis Security Agreement) of Stratis.

The Borrower has requested that certain amendments be made to the Credit Agreement. As one of the conditions precedent to consummate the transactions contemplated by the Second Amendment to Term Loan Agreement and Waiver of Defaults, the Secured Party and the other Lenders have required the execution and delivery of this Agreement.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements herein contained, it is agreed as follows:

1. Defined Terms. Unless otherwise defined herein, capitalized terms used in this Amendment which are defined in the Credit Agreement or the Senior Security Agreement shall have the meanings given to them therein.


2. Security Interest. The Debtors hereby confirm that, pursuant to the Senior Security Agreements, they have each granted the Secured Party a security interest in the Patents and Trademarks to secure payment of the Obligations. As set forth in the Senior Security Agreements, the Security Interest includes security interests in substantially all of the personal property of the Debtors, including the Patents and Trademarks of Rotonics listed on Exhibit A attached hereto and the Patents and Trademarks of Stratis Corporation listed on Exhibit B attached hereto. The Security Interest contained in this Agreement is granted in connection with the Security Interests granted pursuant to the Senior Security Agreements. This Agreement grants only the Security Interest herein described, is not intended to and does not affect any present transfer of title of any trademark registration or application, and makes no assignment and grants no right to assign or perform any other action with respect to any intent to use trademark application, unless such action is permitted under 15 U.S.C. § 1060. The Debtors hereby acknowledge and affirm that the rights and remedies of the Secured Party with respect to the Security Interest in the Patents and Trademarks made and granted hereby (the “**Security Interest**”) are more fully set forth in the Senior Security Agreements, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

3. Miscellaneous. This Amendment may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original and all of which counterparts, taken together, shall constitute one and the same instrument.
