ASSIGNMENT OF TRADEMARK

TO ALL WHOM IT MAY CONCERN, be it known:

WHEREAS Logisoft Corporation, a corporation duly organized and existing under the laws of the State of New York, and having a place of business at 375 Woodcliff Drive, Fairport, New York, 14450 (the "Assignor") has used and continues to use the trademark, "SCHOOL WORLD SOFTWARE" (the "Mark"), registered in the United States Patent and Trademark Office on March 25, 1997, Registration Number 2047768, and


WHEREAS, RMK Holdings, LLC, a limited liability company duly organized and existing under the laws of the State of Delaware, and having a place of business at 375 Woodcliff Drive, Fairport, New York, 14450 (the "Assignee") desires to acquire any and all rights that the Assignor may have in and to the Mark and the registration therefor, together with the goodwill of Assignor's business connected with the Mark, with which the Mark is used and which is symbolized by the Mark (the "Goodwill"), along with the right to recover for damages and profits for past infringements thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor does hereby assign onto the Assignee all right, title and interest in and to the Mark and the registration therefor, together with the Goodwill and the right to recover for damages and profits for past infringements thereof;

The Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's right, title and interest in and to the Mark in the Assignee and to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of Assignor.
