## ASSIGNMENT of TRADEMARK

NOW THEREFORE, for certain good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Personal Representative does hereby sell, assign and transfer to Credo, its legal representatives, successors and assigns, the entire right, title and interest in and to said Assigned Property.


UPON SAID CONSIDERATION, the Personal Representative hereby covenants and agrees with Credo, that the neither she nor the Estate of Donald D. Reitz will

Reitz will, at any time upon request, without further or additional consideration, but at the expense of Credo, execute such additional assignments and other writings and do such additional acts as Credo may deem necessary or desirable to perfect the enjoyment of this grant, and render all necessary assistance in applying for, making and/or obtaining renewal or extended Certificates of Registration in the United States and in any and all foreign countries, of the trademarks included within the Assigned Property, and in enforcing any rights or choses of action accruing as a result of such Assigned Property, by giving evidence and/or providing testimony in any proceedings or transactions involving such Assigned Property, and by executing affidavits and declarations, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the successors, assigns and legal representatives of the parties hereto.





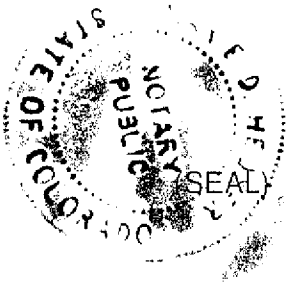
