and generally do all other and further lawful acts, deemed necessary or expedient by the ASSIGNEE or by counsel for ASSIGNEE, to assist or enable the ASSIGNEE to obtain and enforce full benefits from the rights and interests herein assigned. ASSIGNOR additionally agrees to execute copies of this assignment or portions thereof regarding any or all of the aforementioned MARK, as required by ASSIGNEE in the future.


