**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of November 25, 2008 ("Effective Date") by and between General Electric Capital Corporation, successor-in-interest to Heller Financial, Inc., as Agent (as defined in the Trademark Security Agreement defined below), with its principal office at 201 Merritt 7, Norwalk, Connecticut 06856-5201 ("Grantee"), and Portola Packaging, Inc., a Delaware corporation, with its principal office at 951 Douglas Road, Batavia, Illinois 60150 ("Grantor").

**WHEREAS**, Grantor and Grantee are parties to that certain Amended and Restated Credit and Security Agreement dated June 30, 1994 by and between Grantor and Grantee (the "Credit and Security Agreement");

**WHEREAS**, pursuant to the terms and conditions of the Credit and Security Agreement, Grantor and Grantee entered into an Amended and Restated Assignment for Security (Trademarks) (the "Trademark Security Agreement") whereby Grantor granted to Grantee a continuing security interest in, and a continuing lien on, all of Grantor's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations and application set forth on Schedules A and B attached hereto, to secure the payment of all amounts owed by Grantor under the Credit Agreement;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 29, 1994, at Reel 001225, Frame 0391;

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases any and all security interests liens it has against the Trademark Collateral.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
