TRADEMARK ASSIGNMENT

This Trademark Assignment is made this 16th day of September, 2008, by Insolvency Services Group, Inc., as assignee for the benefit of creditors of Ultimate Blackjack Tour, LLC, with its principal place of business at 17401 Ventura Boulevard, Suite B-21, Encino, California 91316 ("Assignor") in favor of Centaurus Games, LLC, a Delaware limited liability company ("Centaurus").

WHEREAS. Assignor and Centaurus have entered into an Asset Purchase Agreement on September 16, 2008 (the "APA") pursuant to which Centaurus has purchased certain personal property from Assignor, including the Marks.

WHEREAS. this Trademark Assignment is being executed in order to memorialize the transfer of title to the Marks acquired by Centaurus as a result of the APA.

NOW, THEREFORE, for a valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Centaurus all of its right, title and interest in and to the Marks and registrations, together with the goodwill of the business symbolized by the Marks and the right to recover and have damages and any profits for past infringement of the Marks, if any. This Assignment is subject to the terms, conditions and provisions of the APA and is not intended to expand or alter the rights, duties or obligations of the parties thereunder.
