**RELEASE OF SECURITY INTEREST

WHEREAS, in connection with the Loan Agreement, and pursuant to those certain agreements listed on the Annex I attached hereto (collectively, the "**Security Agreements**"), Grantor granted security interests in the Trademark Collateral (as such term is defined in the applicable Security Agreement) and the Copyright Collateral (as such term is defined in the applicable Security Agreement), including, without limitation, the intellectual property listed on Annex I attached hereto; and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office and the Copyright Office on the dates set forth on Annex I hereto;



Agent agrees, at the Grantor's expense, to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the Trademark Collateral and the Copyright Collateral.
