U.S. TRADEMARK ASSIGNMENT

This U.S. TRADEMARK ASSIGNMENT ("Assignment") made as of June 30, 2008 by Moe Greene Entertainment, LLC, a limited liability company having a principal place of business at 1601 Broadway, 10th Floor, New York, New York 10019 ("Assignor"), and Creative Group Acquisition Co., a corporation having a principal place of business at 1601 Broadway, 10th Floor, New York, NY 10019 ("Assignee").

Assignor does hereby assign to Assignee all of Assignor's right, title and interest in and to the Assigned Mark and the goodwill of the business connected with the use of and symbolized by the Assigned Mark and the right to sue and recover damages and profits for third-party infringements, including past infringements, if any.

Assignor agrees on behalf of itself, its directors, officers, employees, agents, successors, assigns, and legal representatives to execute any and all papers and instruments and to do any and all acts which may be necessary or reasonably requested by Assignee, in order to carry into full force and effect this sale, assignment and transfer, including without limitation to vest in Assignee or its assigns title in and to the Assigned Mark.

This Assignment may be executed and delivered (including by facsimile transmission or otherwise electronically) simultaneously in counterparts, each of which when executed will be deemed an original but all of which together will constitute one and the same instrument.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States in respect to trademark issues, and in all other respects, including as to validity, interpretation and effect by the internal laws of the State of New York applicable to agreements made and to be performed entirely within such State.
