Recitals

A. Assignor and Assignee have entered into a plan of reorganization pursuant to which Assignor are transferring to Assignee certain trademarks of Assignor, together with the goodwill of the business connected with and symbolized by the trademarks, and including the right to sue for past infringement thereon.

B. Pursuant to the plan of reorganization, Assignor have agreed to execute such instruments as Assignee may reasonably request in order more effectively to assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Assignee of, all of the trademarks.

C. In furtherance of the foregoing, Assignor desires to assign, transfer, grant, convey, assure and confirm to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignors' worldwide right, title and interest in, to and under Assignors' registered trademarks shown below, and any corresponding state or common law trademark rights, including the right to apply for related domestic and foreign trademarks and trademark applications, together with the goodwill of the business connected with and symbolized by the trademarks, including the right to sue for past infringement thereon (all of the foregoing being referred to herein as the "Trademarks").

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignors do hereby sell and assign to Assignee, its successors, assigns, nominees, or other legal representatives, the entire right, title, right and interest in and to all improvements in the following trademarks, together with the goodwill of the business connected with and symbolized by the trademarks, and the right to sue for past infringement thereon:

1. **"MISCELLANEOUS DESIGN (Duckhead),"** having a federal registration number **2,868,659;**
2. **"EST EARLY SEASON TECHNOLOGY,"** having a federal registration number **3,085,866;**
3. **"EST EARLY SEASON TECHNOLOGY(& Design),"** having a federal registration number **3,114,629**

and any and all corresponding applications or registrations for trademark in any and all countries, and authorize and request the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue trademarks, to issue any trademark on said improvements or resulting therefrom to the said "ASSIGNEE," its successors, assigns, nominees or other legal representatives, as assignee of the entire interest, and I covenant that I have full right to convey the entire interest herein assigned and that I have not executed and will not execute any agreement in conflict herewith, and agree that I will communicate to said "ASSIGNEE," its successors, assigns, nominees or other legal representatives all facts known to me respecting said invention, whenever requested, and testify in any legal proceeding, sign all lawful papers, make all rightful oaths and do all


lawful acts requisite to perfect and maintain such trademarks, Assignor will, upon request, sign all lawful papers requisite to perfect and maintain such trademarks, and Assignor further covenants and agrees that it will, at any time upon request, do everything legally possible to aid said "ASSIGNEE," its successors, assigns, nominees or other legal representatives, either in its own name, to apply for, obtain and enforce the trademarks in all countries, all without further consideration but at the expense of said "ASSIGNEE," his successors, assigns, nominees, or other legal representatives.




