

## CONFIRMATIVE TRADEMARK ASSIGNMENT

THIS CONFIRMATIVE TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of November 1st, 2008 ("Effective Date"), by and between Alcatel-Lucent USA Inc., a Delaware corporation having its principal place of business at 600 Mountain Avenue, Murray Hill, New Jersey 07974 ("ALU USA"), and Alcatel USA Marketing, Inc., a Delaware corporation having its principal place of business at 600 Mountain Avenue, Murray Hill, New Jersey 07974 ("Alcatel Marketing").

WHEREAS, as of 12:01 a.m. on the Effective Date, pursuant to a certificate of merger filed with the Secretary of State of the State of Delaware, Alcatel Marketing merged with and into Lucent Technologies, Inc. (the "Merger") in accordance with an Agreement of Merger, dated as of October 17, 2008 ("Merger Agreement"), and simultaneously with the Merger Lucent Technologies Inc. changed its legal name into Alcatel-Lucent USA Inc.

WHEREAS, immediately prior the Merger, Alcatel Marketing was the owner of the trademark registrations as set forth on Schedule A hereto ("Assigned Trademarks").

WHEREAS, Alcatel Marketing desires to confirm the transfer and assign to ALU USA, and ALU USA desires to confirm its acquisition from Alcatel Marketing, of all of Alcatel Marketing's right, title and interest in and to the Assigned Trademarks.

NOW, THEREFORE, for good and valuable consideration more fully described in the Merger Agreement, Alcatel Marketing hereby confirms that, as a result of the Merger, Alcatel Marketing has transferred, conveyed and assigned to ALU USA, which has accepted, all right, title and interest in and to the Assigned Trademarks, together with the goodwill of the business connected with and symbolized by the Assigned Trademarks, and the right to sue and recover for past infringement of the Assigned Trademarks.
