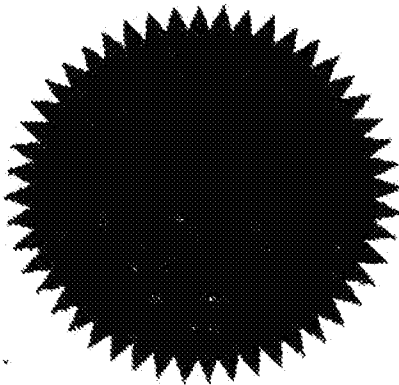

TO
SECOND AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
VERASUN ENERGY CORPORATION

Pursuant to the provisions of Section 47-1A-1003 of the South Dakota Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Second Amended and Restated Articles of Incorporation, as amended.

FIRST: The name of the corporation is VERASUN ENERGY CORPORATION (organizational ID# DB044362).

SECOND: Article FIRST of the Second Amended and Restated Articles of Incorporation of the corporation was amended to read as follows:

The name of the corporation shall be:
VERASUN AURORA CORPORATION.


THIRD: The amendment does not provide for any exchange, reclassification or cancellation of issued shares.

FOURTH: The amendment to Article FIRST of the Second Amended and Restated Articles of Incorporation of the corporation was adopted on October 11, 2005.
