## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment") is entered into as of September 22, 2008 (the "Effective Date") by ChartOne, Inc., a Delaware corporation having a principal place of business at 3 New England Executive Park, Suite 200, Burlington, Massachusetts, 01803 ("Assignor") in favor of eWebHealth, Inc., a Delaware based company with a principal place of business at 55 Walkers Brook Drive, Reading, Massachusetts, 01867 ("Assignee").

WHEREAS, Assignor and Assignee entered into that certain Assignment and Assumption Agreement on September 22, 2008 (the "Assumption Agreement");

WHEREAS, pursuant to the Assumption Agreement, Assignor wishes to confirm that it has transferred to Assignee all right, title and interest, including all of the goodwill of the business symbolized thereby and associated therewith, in and to the trademarks listed in the attached Schedule A (the "Trademarks"); and

WHEREAS, Assignee is the successor to that portion of the assets of the business of the Assignor to which the Trademarks pertain and such business is ongoing.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned and transferred to Assignee, as of the Effective Date, all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by and associated with the Trademarks and including, without limitation, all common law rights in and to the Trademarks and the right to sue and recover for, and the right to profits or damages due or accrued or arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Trademarks as


of the Effective Date, to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had such assignment not been made.

Assignor covenants and agrees to execute and deliver such other documents as Assignee may reasonably request for the purposes of transferring, recording or otherwise effectuating or perfecting the transfer and assignment of the Trademarks confirmed herein and as originally contemplated herein.

This Assignment is provided pursuant to the Assumption Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Trademarks.


