In compliance with the requirements of section 18-209 of the Delaware Limited Liability Company Act ("Delaware Act") and section 14A:10-14 of the New Jersey Business Corporation Act ("NJBCA"), the undersigned, desiring to effect a merger, hereby state that:

1. The name of the limited liability company surviving the merger is Alliance Global Services, LLC, a Delaware limited liability company (the "Surviving Limited Liability Company"). The name of the merging corporation is Alliance Consulting Group Associates, Inc., a New Jersey corporation ("Merging Corporation").
2. An Agreement and Plan of Merger was approved and executed by consent of the sole member of the Surviving Limited Liability Company in accordance with section 18-209 of the Delaware Act. Such agreement and plan of merger was approved, adopted, certified, executed and acknowledged by consent of the sole stockholder and was unanimously approved by the board of directors of the Merging Corporation in accordance with section 14A:10-4.1 of the NJBCA on August 4, 2008.

4. This Certificate of Merger shall become effective upon the filing of this Certificate of Merger.
5. The Limited Liability Company Agreement of Alliance Global Services, LLC shall be the governing agreement of the Surviving Company.

7. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Limited Liability Company, on request and without cost, to any stockholder of the Merging Corporation and any member of the Surviving Limited Liability Company.
8. The Surviving Limited Liability Company shall be served with process in the State of New Jersey in any proceeding for the enforcement of any obligation of the Merging Corporation. The Surviving Limited Liability Company irrevocably appoints the Department of Treasury of the State of New Jersey as its agent to accept service of process in any such proceeding.

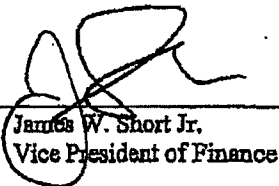

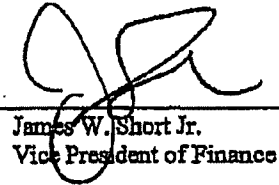
