MEMORANDUM OF RELEASE OF SECURITY INTEREST

Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of March 28, 2008, executed by Annie's, Inc. (the "Company"), Annie's Enterprises, Inc., Annie's Homegrown, Inc. ("Homegrown"), Fantastic Foods, Inc. ("Fantastic") and Napa Valley Kitchens, Inc. (collectively the "Borrowers"), in favor of Hercules Technology II, L.P. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender, hereby releases, retransfers and reassigns to Homegrown and Fantastic, without representation or warranty, all right, title and interest in and to the Marks and the goodwill associated therewith in which Lender held or currently holds an interest.



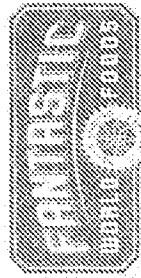
