NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the ASSIGNOR does hereby confirm the assignment, transfer and voluntary asset surrender as of March 10, 2005 of the ASSIGNOR'S entire right, title and interest in and to the MARKS, together with the goodwill of the business in connection with which the MARKS were used and which was symbolized by the MARKS, as fully and entirely as the same would have been held and enjoyed by him if this Assignment had not been made, including the right to pursue all actions based on such MARKS and to recover for past infringement or violations of law relating to said MARKS, the same to be held and enjoyed by the ASSIGNEE and its legal representatives, successors and assigns, for its own use and enjoyment, and for the use and enjoyment of its assigns, successors, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this Assignment not been made.

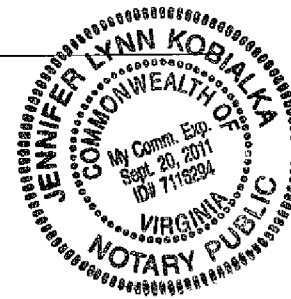
This Confirmatory Assignment confirms the assignment of said MARKS through the Voluntary Asset Surrender Agreement made as of March 10, 2005.
