## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made and effective as of the 4th day of December 2008 (the “**Effective Date**”) and is granted by **NEWSTAR FINANCIAL, INC.**, a Delaware corporation (the “**Administrative Agent**”).

WHEREAS, the Grantors listed on the signature pages to that certain Trademark Security Agreement who are **HACKNEY LADISH, INC.**, a Delaware corporation, and **HACKNEY LADISH HOLDING CORP.**, a Delaware corporation (“**Releasees**”), dated as of October 10, 2007 (the “**Trademark Security Agreement**”), entered into the Trademark Security Agreement in favor of the Administrative Agent, pursuant to which the Releasees granted to the Administrative Agent a continuing security interest in all of the Releasees’ right, title and interest in, to and under the trademarks listed on the annexed Schedule A (the “**Trademark Collateral**”), to secure the payment, performance and observance of the obligations referred to therein;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office at Reel 003638, Frame 0829 on October 11, 2007; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Trademark Collateral, and the Administrative Agent reassigns any and all such right, title and interest that it may have in the Trademark Collateral to the Releasees.

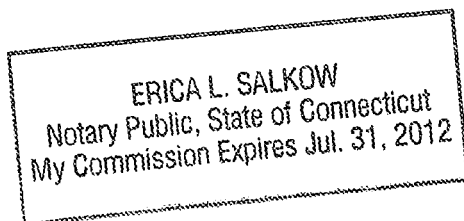
