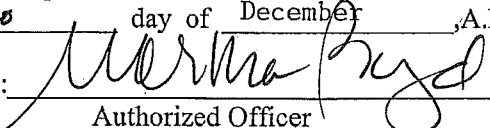
FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
