RELEASE OF COLLATERAL ASSIGNMENT (TRADEMARKS)

THIS RELEASE dated as of **December 3, 2008** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Collateral Assignment (Trademarks), dated as of **June 19, 1998** and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Extrusion Dies, Inc.**, (the "Debtor") and the Secured Party;

W I T N E S S E T H:

WHEREAS, pursuant to the Security Agreement which was recorded in the records of the United States Patent and Trademark Office, the Debtor granted to the Secured Party a continuing security interest in all of the Debtor's United States Intellectual Property Collateral including those set forth;


WHEREAS, the Secured Party wishes to: (i) terminate the Security Agreement against the Intellectual Property Collateral, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest covering the Intellectual Property Collateral; (iii) restore all right, title and interest in and to the Intellectual Property Collateral, to Debtor; and (iv) to dissolve any and all liens and encumbrances respecting the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the

Intellectual Property Collateral including those set forth, and discharges, quit claims and relinquishes unto **Extrusion Dies, Inc.**, (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interest granted to Secured Party in the Intellectual Property Collateral.

IN WITNESS WHEREOF, the Secured Party has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the day and year first above written.


