AMENDED AND RESTATED THIRD PRIORITY INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS AMENDED AND RESTATED THIRD PRIORITY INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of October 8, 2008, is entered into by and among CYGNUS BUSINESS MEDIA, INC., a Delaware corporation ("Borrower"), the direct or indirect subsidiaries of Borrower party hereto from time to time (collectively, together with the Borrower, the "Grantors"), and GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation ("GE Capital"), acting in its capacity as the Collateral Agent for the Secured Creditors described below (the "Collateral Agent").

Statement of Facts

- A. Pursuant to that certain Credit Agreement, dated as of July 13, 2004, by and among the Borrower, any other Grantors signatory thereto, the lenders parties thereto from time to time (collectively, the "Lenders"), and GE Capital, acting in its capacity as agent for the Lenders thereunder (the "Lender Agent") (said agreement, as from time to time amended, supplemented or restated, the "Lender Credit Agreement"), the Lenders and the Lender Agent have agreed to make certain loans to the Borrower (collectively, the "Loans") and to incur certain letter of credit obligations for the benefit of the Borrower (collectively, the "Letter of Credit Obligations"). The Borrower's indebtedness and obligations to Lenders and the Lender Agent under or with respect to the Lender Credit Agreement are being guaranteed by all of the other Grantors pursuant to the Lender Credit Agreement and the Subsidiary Guaranty (as defined in the Lender Credit Agreement).
- B. In order to induce the Lender Agent and the Lenders to enter into the Lender Credit Agreement and other Lender Credit Documents and to make the Loans and to incur the Letter of Credit Obligations as provided for in the Lender Credit Agreement, Grantors entered into that certain Third Priority Intellectual Property Security Agreement dated as of July 13, 2004 with the Collateral Agent (the "Original Third Priority Intellectual Property Security Agreement").
- C. Each Grantor and the Collateral Agent desire to amend and restate the Original Third Priority Intellectual Property Security Agreement in its entirety pursuant to the terms and conditions hereof.
- D. Pursuant to that certain Amended and Restated Collateral Agency and Intercreditor Agreement, dated as of April 26, 2007, by and between GE Capital and the SCIL Lender Agent (as defined in the Intercreditor Agreement defined below) and consented to by the Grantors (as from time to time amended, restated, supplemented or otherwise modified, the "Intercreditor Agreement"), GE Capital has been appointed Collateral Agent with respect to, inter alia, the grant of all Intellectual Property Collateral (as herein defined) hereunder to secure the Secured Obligations (as defined below) in order to facilitate the granting of the security interests and Liens hereunder and otherwise to secure the Secured Obligations and to establish the relative priority of the Secured Obligations with respect to such security interests and Liens.

- **NOW, THEREFORE**, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby agrees as follows:
- 1. <u>Definitions</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Intercreditor Agreement or, if not defined therein, then in the Controlling Secured Document (and in the event of a conflict between the definition of any term in such documents, the definition of such term in the Intercreditor Agreement shall control), and the following terms shall have (unless otherwise provided elsewhere in this Amended and Restated Third Priority Intellectual Property Security Agreement) the following respective meanings (such meanings being equally applicable to both the singular and plural form of the terms defined):
- (a) "<u>Third Priority Liens</u>" shall have the meaning given such term in Section 2(a) of this Agreement.
- (b) "Intellectual Property Collateral" shall mean all of the right, title and interest of such Grantors in, to and under the following, whether presently existing or hereafter created or acquired:
 - (i) all of its Patents and Patent Licenses to which it is a party including those referred to on Schedule I hereto;
 - (ii) all of its Trademarks and Trademark Licenses to which it is a party including those referred to on Schedule II hereto;
 - (iii) all of its Copyrights and Copyright Licenses to which it is a party including those referred to on <u>Schedule III</u> hereto;
 - (iv) all reissues, continuations or extensions of the foregoing;
 - (v) all goodwill of the business connected with the use of, and symbolized by, each Patent, each Patent License, each Trademark, each Trademark License, each Copyright and each Copyright License; and
 - (vi) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement of any Patent or Patent licensed under any Patent License, (ii) injury to the goodwill associated with any Patent or any Patent licensed under any Patent License, (iii) infringement or dilution of any Trademark or Trademark licensed under any Trademark License, (iv) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License, (v) infringement of any Copyright or Copyright licensed under any Copyright License, and (vi) injury to the goodwill associated with any Copyright or any Copyright licensed under any Copyright License.
- (c) "Intercreditor Agreement" has the meaning given such term in the Statement of Facts above.

- (d) "Lender Agent" has the meaning given such term in the Statement of Facts above.
- (e) "Lender Credit Agreement" has the meaning given such term in the Statement of Facts above.
- (f) "<u>Lenders</u>" has the meaning given such term in the Statement of Facts above.
- (g) "Permitted Encumbrance" shall mean a "Permitted Encumbrance" under and as defined in the Controlling Secured Document.
- (h) "Secured Creditors" means any holder from time to time of any Secured Obligation and shall include the Collateral Agent and shall include any Secured Creditor Representative.
- (i) "Secured Obligations" means any and all Lender Indebtedness (excluding Excess Lender Indebtedness) and any and all Replacement Lender Indebtedness (excluding the Excess Replacement Lender Indebtedness).
- (j) "<u>Termination Date</u>" means the later of the Termination Date under (and as defined in) the Lender Credit Agreement and the Replacement Lender Credit Agreement.

All other terms contained in this Intellectual Property Security Agreement, unless the context indicates otherwise, have the meanings provided for by the Code to the extent the same are used or defined therein. Unless otherwise expressly provided herein, references to any agreement or contract herein are to such agreement or contract as amended, modified or supplemented from time to time in accordance with the terms hereof and thereof, and in the case of the Lender Credit Agreement or any Replacement Lender Credit Agreement includes any amendment, modification, supplement, restatement, replacement or refinancing (in whole or in part) thereof, whether by way of increase or reduction to the principal amount thereof, addition or elimination of any credit facilities thereto, extension of term, addition or deletion of any party thereto or otherwise.

2. Grant of Security Interests.

(a) To secure the prompt and complete payment and performance of all of the Lender Indebtedness (other than Excess Lender Indebtedness) and Replacement Lender Indebtedness (other than Excess Replacement Lender Indebtedness) when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise (including the payment of amounts that would become due but for the operation of the automatic stay under the Federal Bankruptcy Code (and any successor provision thereof)), each Grantor hereby grants, assigns, conveys, mortgages, pledges, hypothecates and transfers to Collateral Agent, for itself and the benefit of the Lenders, the Lender Agent, the Replacement Lenders and the Replacement Lender Agent, a continuing security interest and Lien upon all of the right, title and interest to and under the Intellectual Property Collateral. The continuing security interest and Lien granted above in this Section 2(a) by Grantors to Collateral Agent, for itself and the benefit of the Lenders, the Lender Agent, the Replacement Lenders and the Replacement Lender Agent are

referred to herein as the "Third Priority Liens." Notwithstanding anything to the contrary contained herein, this Intellectual Property Security Agreement and the Third Priority Liens granted hereunder are subject to the terms and conditions of the Intercreditor Agreement.

- (b) Notwithstanding the foregoing, the "Intellectual Property Collateral" shall not include (i) any personal property that is leased by any Grantor or any rights of such Grantor under such lease (other than such Grantor's rights to payment under such lease constituting Accounts or General Intangibles for money due or to become due) if and for so long as the grant of a security interest by such Grantor in such personal property or lease violates the terms of such Grantor's lease of such personal property; provided that the Grantor shall be deemed to have granted security interests to the Collateral Agent for itself and the benefit of the applicable Secured Creditors as provided in Section 2(a) in such leased personal property, and such personal property shall be included in the Intellectual Property Collateral, at such time that such grant no longer violates such lease; and (ii) any General Intangibles or other rights arising under any written contracts, instruments, licenses or other documents executed on arm's length terms as to which, and only to the extent which, the grant of a security interest would (A) constitute a violation of a valid and enforceable restriction in favor of a third party (other than an Affiliate of any Credit Party) on such grant, (B) give any other party (other than an Affiliate of any Credit Party) to such contract, instrument, license or other document the right to terminate its obligations thereunder or (C) result in the abandonment, invalidation or unenforceability of any right, title or interest of such Grantor thereunder (other than to the extent that any such term or restriction would be rendered ineffective pursuant to Section 9-406, 9-407, 9-408 or 9-409 of the Code (or any successor provision or provisions) of any relevant jurisdiction or any other applicable law (including the Federal Bankruptcy Code) or principles of equity), in each case unless and until any required consents shall have been obtained, provided that each Grantor shall use its best efforts to obtain consents for any General Intangibles or other rights arising under any contracts, instruments, licenses or other documents which are material to the operation of such Grantor's business (which best efforts shall not require that any Grantor pay any fee or other sum not already specified in such contracts, instruments, licenses or other documents or that any Grantor agree to an amendment of the underlying transaction giving rise to such restriction), provided further that such Grantor shall be deemed to have granted security interests to the Collateral Agent for itself and the benefit of the applicable Secured Creditors as provided in Section 2(a) in such General Intangibles or other rights, and such General Intangibles or other rights shall be included in the Collateral, at such time that such grant does not result in any of the consequences specified in the foregoing subclauses (A), (B) and (C) of this clause (ii).
- Representations and Warranties. Each Grantor represents and warrants to the Collateral Agent and the other Secured Creditors that, as of the date hereof, such Grantor does not have any interest in, or title to, any Patent, registered Trademark, Trademark application, or registered Copyright except as set forth in Schedule I, Schedule II and Schedule III, respectively, hereto. This Amended and Restated Third Priority Intellectual Property Security Agreement is effective to create valid and continuing Liens on and, upon the recording hereof with the United States Copyright Office and the United States Patent and Trademark Office and the filing of appropriate financing statements in the jurisdictions listed on Schedule I to the Security Agreement, perfected Liens in favor of Collateral Agent (for the benefit of itself and the other Secured Creditors as provided in Section 2(a) above) on each Grantor's Patents, Trademarks and Copyrights, to the extent such perfection can be achieved by making such filings, and such

perfected Liens are enforceable as such as against any and all creditors of and purchasers from any Grantor.

- 4. <u>Covenants</u>. Each Grantor covenants and agrees with the Collateral Agent that from and after the date of this Amended and Restated Third Priority Intellectual Property Security Agreement and until the Termination Date:
- (a) Grantors shall notify Collateral Agent in accordance with Section 5(a)(ix) of the Security Agreement if any Grantor knows or have reason to know that any application or registration relating to any Patent, Trademark or Copyright (now or hereafter existing) may become abandoned or dedicated (except where as a result of Grantor's decision to allow the same to lapse or become abandoned because it is no longer in any way material to the conduct of its business or operations), or of any adverse determination or development (including the institution of, or any such determination or development in, any proceeding in the United States Patent and Trademark Office, the United States Copyright Office or any court) regarding any Grantor's ownership of any Patent, Trademark or Copyright, its right to register the same, or to keep and maintain the same.
- (b) In the event any Grantor shall, either directly or through any agent, employee, licensee or designee, file an application for the registration of any Patent, Trademark or Copyright with the United States Patent and Trademark Office, the United States Copyright Office or any similar office or agency upon request of Collateral Agent, such Grantor shall execute and deliver a supplement hereto (in form and substance satisfactory to the Collateral Agent) to evidence Collateral Agent's Liens on such Patent, Trademark or Copyright, and the General Intangibles of such Grantor relating thereto or represented thereby.
- (c) Grantors shall take all actions necessary or requested by Collateral Agent to maintain and pursue each application, to obtain the relevant registration and to maintain the registration of each of the Patents, Trademarks and Copyrights (now or hereafter existing), including the filing of applications for renewal, affidavits of use, affidavits of noncontestability and opposition and interference and cancellation proceedings.
- (d) In the event that any of the Intellectual Property Collateral is infringed upon, or misappropriated or diluted by a third party, such Grantor shall, unless it shall reasonably determine that such Intellectual Property Collateral is in no way material to the conduct of its business or operations, promptly take all appropriate action, which may include suing for infringement, misappropriation or dilution to recover any and all damages for such infringement, misappropriation or dilution, and shall take such other actions as the Collateral Agent shall deem appropriate under the circumstances to protect such Intellectual Property Collateral.
- 5. <u>Security Agreement</u>. The security interests and Liens granted by each Grantor pursuant to this Amended and Restated Third Priority Intellectual Property Security Agreement are granted in conjunction with the security interests and Liens granted by each Grantor to Collateral Agent, on behalf of itself and the other Secured Creditors, pursuant to the Security Agreement. Each Grantor and Collateral Agent expressly agree that each of the security interests granted under this Intellectual Property Security Agreement and the Security Agreement in the Intellectual Property Collateral are intended to be treated as a single security interest for purposes

of Article 9 of the Code and other applicable law. The exercise by the Collateral Agent or any other Secured Creditor of any rights or remedies with respect to any of the Intellectual Property Collateral shall be deemed to be an exercise of such rights or remedies in connection with both this Intellectual Property Security Agreement and the Security Agreement. In the event of any inconsistency between the terms and conditions of this Intellectual Property Security Agreement and the Security Agreement, then the terms and conditions of the Security Agreement shall prevail. All proceeds of the Collateral Agent's exercise of its rights and remedies hereunder or under the Security Agreement or applicable law with respect to all or any of the Intellectual Property Collateral shall be applied in accordance with the terms of the Intercreditor Agreement. The Collateral Agent may make distributions hereunder in cash or, if Collateral Agent receives proceeds consisting of property other than cash, in kind, in such property, on a ratable basis, in any combination thereof.

- Security Agreement shall remain in full force and effect and continue to be effective should any petition be filed by or against any Grantor for liquidation or reorganization, should any Grantor become insolvent or make an assignment for the benefit of any creditor or creditors or should a receiver or trustee be appointed for all or any significant part of any Grantor's assets, and shall continue to be effective or be reinstated, as the case may be, if at any time payment and performance of the Secured Obligations, or any part thereof, is, pursuant to applicable law, rescinded or reduced in amount, or must otherwise be restored or returned by any obligee of the Secured Obligations, whether as a "voidable preference," "fraudulent conveyance," or otherwise, all as though such payment or performance had not been made. In the event that any payment, or any part thereof, is rescinded, reduced, restored or returned, the Secured Obligations shall be reinstated and deemed reduced only by such amount paid and not so rescinded, reduced, restored or returned.
- 7. Notices. Except as otherwise provided herein, whenever it is provided herein that any notice, demand, request, consent, approval, declaration or other communication shall or may be given to or served upon any of the parties by any other party, or whenever any of the parties desires to give and serve upon any other party any communication with respect to this Intellectual Property Security Agreement, each such notice, demand, request, consent, approval, declaration or other communication shall be in writing and shall be given in the manner, and deemed received, as provided for in the notice provisions of the Controlling Secured Document.
- 8. <u>Termination</u>. Subject to <u>Section 6</u> hereof, this Amended and Restated Third Priority Intellectual Property Security Agreement shall terminate upon the Termination Date. At any time and from time to time prior to the Termination Date, the Collateral Agent may release any of the Intellectual Property Collateral in accordance with the terms of the Intercreditor Agreement. Upon any such termination of the Liens created hereunder upon the Termination Date, or any such release of Intellectual Property Collateral prior to the Termination Date, the Collateral Agent will, at the expense of the Grantors, promptly execute and deliver to the Grantors such documents as the Grantors shall reasonably request to evidence the termination of the Liens created hereby or the release of such Intellectual Property Collateral, as the case may be.

- Governing Law. EXCEPT AS OTHERWISE EXPRESSLY PROVIDED IN ANY OF THE LOAN DOCUMENTS, IN ALL RESPECTS, INCLUDING ALL MATTERS OF CONSTRUCTION, VALIDITY AND PERFORMANCE, THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT AND THE OBLIGATIONS ARISING HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERANAL LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS MADE AND PERFORMED IN THAT STATE, AND ANY APPLICABLE LAWS OF THE UNITED STATES OF AMERICA. EACH GRANTOR HEREBY CONSENTS AND AGREES THAT THE STATE OR FEDERAL COURTS LOCATED IN NEW YORK COUNTY, CITY OF NEW YORK, NEW YORK, SHALL HAVE EXCLUSIVE JURISDICTION TO HEAR AND DETERMINE ANY CLAIMS OR DISPUTES AMONG ANY GRANTOR, COLLATERAL AGENT AND SECURED CREDITORS PERTAINING TO THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT OR ANY OF THE OTHER SECURITY DOCUMENTS OR TO ANY MATTER ARISING OUT OF OR RELATING TO THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT OR ANY OF THE OTHER SECURITY DOCUMENTS; PROVIDED, THAT COLLATERAL AGENT, THE OTHER SECURED CREDITORS AND EACH GRANTOR ACKNOWLEDGE THAT ANY APPEALS FROM THOSE COURTS MAY HAVE TO BE HEARD BY A COURT LOCATED OUTSIDE OF NEW YORK COUNTY, NEW YORK, AND, PROVIDED, FURTHER, THAT NOTHING IN THIS INTELLECTUAL PROPERTY AGREEMENT SHALL BE DEEMED OR OPERATE TO PRECLUDE COLLATERAL AGENT FROM BRINGING SUIT OR TAKING OTHER LEGAL ACTION IN ANY OTHER JURISDICTION TO REALIZE ON THE INTELLECTUAL PROPERTY COLLATERAL OR ANY OTHER SECURITY FOR THE SECURED OBLIGATIONS, OR TO ENFORCE A JUDGMENT OR OTHER COURT ORDER IN FAVOR OF COLLATERAL AGENT FOR THE BENEFIT OF ITSELF AND THE OTHER SECURED CREDITORS. EACH GRANTOR EXPRESSLY SUBMITS AND CONSENTS IN ADVANCE TO SUCH JURISDICTION IN ANY ACTION OR SUIT COMMENCED IN ANY SUCH COURT, AND EACH GRANTOR HEREBY WAIVES ANY OBJECTION WHICH IT MAY HAVE BASED UPON LACK OF PERSONAL JURISDICTION, IMPROPER VENUE OR FORUM NON CONVENIENS AND HEREBY CONSENTS TO THE GRANTING OF SUCH LEGAL OR EQUITABLE RELIEF AS IS DEEMED APPROPRIATE BY SUCH EACH GRANTOR HEREBY WAIVES PERSONAL SERVICE OF THE SUMMONS, COMPLAINT AND OTHER PROCESS ISSUED IN ANY SUCH ACTION OR SUIT AND AGREES THAT SERVICE OF SUCH SUMMONS, COMPLAINTS AND OTHER PROCESS MAY BE MADE BY REGISTERED OR CERTIFIED MAIL ADDRESSED TO SUCH GRANTOR AT THE ADDRESS SET FORTH IN THE APPLICABLE NOTICE SECTION OF THE CONTROLLING SECURED DOCUMENT AND THAT SERVICE SO MADE SHALL BE DEEMED COMPLETED UPON THE EARLIER OF THE ACTUAL RECEIPT THEREOF OR THREE (3) BUSINESS DAYS AFTER DEPOSIT IN THE U.S. MAIL, PROPER POSTAGE PREPAID.
- 10. WAIVER OF JURY TRIAL. BECAUSE DISPUTES ARISING IN CONNECTION WITH COMPLEX FINANCIAL TRANSACTIONS ARE MOST QUICKLY AND ECONOMICALLY RESOLVED BY AN EXPERIENCED AND EXPERT PERSON AND THE PARTIES DESIRE APPLICABLE STATE AND FEDERAL LAWS TO APPLY (RATHER THAN ARBITRATION RULES), THE PARTIES DESIRE THAT THEIR DISPUTES BE RESOLVED BY A JUDGE APPLYING SUCH APPLICABLE LAWS.

THEREFORE, TO ACHIEVE THE BEST COMBINATION OF THE BENEFITS OF THE JUDICIAL SYSTEM AND OF ARBITRATION, THE PARTIES HERETO, AND BY ITS ACCEPTANCE OF THE BENEFITS HERETO, THE COLLATERAL AGENT AND EACH OTHER SECURED CREDITOR, WAIVE ALL RIGHT TO TRIAL BY JURY IN ANY ACTION, SUIT OR PROCEEDING BROUGHT TO RESOLVE ANY DISPUTE, WHETHER SOUNDING IN CONTRACT, TORT, OR OTHERWISE, AMONG COLLATERAL AGENT, THE SECURED CREDITORS AND GRANTORS ARISING OUT OF, CONNECTED WITH, RELATED TO, OR INCIDENTAL TO THE RELATIONSHIP ESTABLISHED IN CONNECTION WITH, THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT OR ANY OF THE OTHER SECURITY DOCUMENTS OR THE TRANSACTIONS RELATED HERETO OR THERETO.

- 11. <u>Concerning the Collateral Agent</u>. The provisions of the Intercreditor Agreement shall inure to the benefit of the Collateral Agent in respect of this Amended and Restated Third Priority Intellectual Property Security Agreement and shall be binding upon the parties hereto and thereto in such respect.
- 12. Appointment of Co-Agents. At any time or times, in order to comply with any legal requirement in any jurisdiction, the Collateral Agent may appoint another bank or trust company or one or more other persons, either to act as co-agent or co-agents, jointly with the Collateral Agent, or to act as separate agent or agents on behalf of the Secured Creditors with such power and authority as may be necessary for the effectual operation of the provisions hereof and may be specified in the instrument of appointment (which may, in the discretion of the Collateral Agent, include provisions for the protection of such co-agent or separate agent similar to the provisions referred to in Section 10).
- Expenses. In the event that any Grantor fails to comply with the provisions of this Intellectual Property Security Agreement or any Security Document, such that the value of any Intellectual Property Collateral or the validity, perfection, rank or value of any Lien created hereunder is thereby diminished or potentially diminished or put at risk, the Collateral Agent if requested by the Controlling Secured Creditor may, but shall not be required to, provided that an Event of Default has occurred and is continuing, effect such compliance on behalf of such Grantor, and such Grantor shall reimburse the Collateral Agent for the costs thereof on demand. All expenses of protecting, maintaining, selling and disposing of the Intellectual Property Collateral shall be borne and paid by the Grantor owning such Intellectual Property Collateral; and if such Grantor fails to promptly pay any portion thereof when due, the Collateral Agent may, at its option, but shall not be required to, pay the same and charge such Grantor's account therefor, and such Grantor agrees to reimburse the Collateral Agent therefor on demand; provided that, so long as the Collateral Agent shall be the same Person as the Lender Agent, the indemnification and reimbursement provisions of the Lender Credit Agreement (as such term is defined in the Intercreditor Agreement) shall control as to the amount and timing of the reimbursement of such expenses. All sums so paid or incurred by the Collateral Agent for any of the foregoing and any and all other sums for which any Grantor may become liable hereunder and all out-of-pocket costs and expenses (including reasonable attorneys' fees, legal expenses and court costs) incurred by the Collateral Agent in enforcing or protecting the security interests created hereunder or any of its rights or remedies under this Intellectual Property Security

Agreement, shall, together with interest thereon until paid at the applicable rate provided in the Controlling Secured Document, be additional Secured Obligations hereunder.

- 14. Other Permitted Intellectual Property Security Agreements. Concurrently with its execution and delivery of this Amended and Restated First Priority Intellectual Property Security Agreement, Grantors have also executed and delivered the following additional intellectual property security agreements with respect to the Intellectual Property Collateral, each in favor of the Collateral Agent: (i) Amended and Restated First Priority Intellectual Property Security Agreement"); and (ii) Amended and Restated Second Priority Intellectual Property Security Agreement (the "Second Priority Intellectual Property Security Agreement (the "Second Priority Intellectual Property Security Agreement are herein collectively referred to as the "Other Permitted Intellectual Property Security Agreements"). This Amended and Restated Third Priority Intellectual Property Security Agreement is junior and subordinate in terms of priority to the Other Permitted Intellectual Property Security Agreement Security Agreements.
- Intellectual Property Security Agreement. This Amended and Restated Third Priority Intellectual Property Security Agreement renews, modifies, amends, restates, supersedes and replaces the Original Third Priority Intellectual Property Security Agreement, but the parties do not intend to effectuate a novation or extinguishment of the original security agreement, and the liens and security interest granted under the Original Third Priority Intellectual Property Security Agreement shall continue in full force and effect, as modified by and as set forth in this Amended and Restated Third Priority Intellectual Property Security Agreement, and shall secure the Secured Obligations.
