ASSIGNMENT OF TRADEMARK RIGHTS NUNC PRO TUNC

WHEREAS, BOSTON SCIENTIFIC SCIMED, INC., a Minnesota corporation (“Assignor”) is the owner of certain trademark applications set forth in the attached Schedule I (collectively, the “Trademark Applications”), and desires to assign to RADIUS INTERNATIONAL, L.P., an Illinois limited partnership (“Assignee”), effective *nunc pro tunc*, now for then, as of the 28th day of May 2008, all of the right, title, and interest in and to the Trademark Applications;

WHEREAS, Assignee has acquired that portion of Assignor’s business in connection with which Assignor had a *bona fide* intent to use the Mark, as specified in the Agreement of Settlement and Release entered into by both parties on May 28, 2008, and the pending Trademark Applications, and wishes to acquire all of the right, title, and interest in and to the Trademark Applications.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, sells and transfers unto Assignee, its successors and assigns, all of the right, title and interest, throughout the world in perpetuity in and to, the Trademark Applications and any registrations thereof. Assignor assigns, sells and transfers said Trademark Applications together with that portion of Assignor’s business that Assignor has assigned to Assignee as specified in the Agreement of Settlement and Release entered into by both parties on May 28, 2008, in connection with which Assignor had a *bona fide* intent to use the Mark, and the goodwill of that portion of the business symbolized by and associated with said Trademark Applications. The rights assigned include any and all causes of action and rights of recovery for past or future infringements of said Trademark Applications or any registration thereof, and all of the rights vested in the Assignor herein by virtue of the instruments of assignment and/or by virtue of other instruments pursuant to which Assignor became/becomes vested with said ownership. Assignor further assigns, transfers and conveys unto said Assignee the entire right, title and interest in and to, and the goodwill of that portion of the business symbolized by and

associated with, any foreign trademarks or trademark applications and/or the rights to file the same, which are counterparts to the Trademark Applications of the United States herein assigned.
