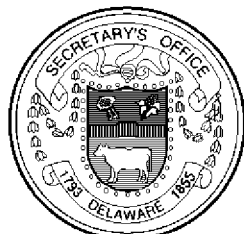

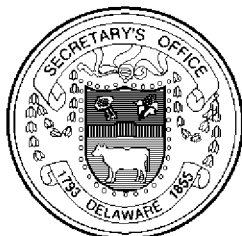

**First: The name of the Corporation is Kingspan-Medusa Inc.**

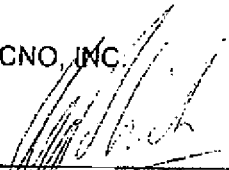
