The undersigned, Richard Smith, hereby certifies that he is and at all times herein mentioned has been, the duly elected and acting Secretary of Pensar Corporation, Wisconsin corporation (the "Corporation"), and further certifies that this restatement contains shareholder approval and was adopted in accordance with Chapter 180.1003.

1. The Second Restated Articles of Incorporation of the Corporation set forth below were adopted by the shareholders of the Corporation on August 21, 2000. The Second Restated Articles of Incorporation, which supersede and take the place of the existing Articles of Incorporation of the Corporation, and any amendment thereto, are as follows:

The name of the corporation is SMTC Manufacturing Corporation of Wisconsin. ^{OK}

ARTICLE II AUG 24 12:00PM

The purpose or purposes for which the Corporation has organized is to engage in any lawful activity for which corporations may be organized under Chapter 180, Wisconsin Statutes.

ARTICLE III.

The aggregate number of shares which the Corporation shall be authorized to issue is 50,000 shares consisting of 10,000 shares of \$1.00 par value, Class A Voting Common Stock and 40,000 shares of \$1.00 par value, Class B Nonvoting Common Stock.

ARTICLE IV.

The preferences, limitations, designations and relative rights of each class of stock are identical except that the Class B Nonvoting Common Stock shall not have any voting rights in the Corporation except those rights expressly set forth in Chapter 180, Wisconsin Statutes, or any successor statute.

ARTICLE V.

The address of the registered office of the Corporation is 25 West Main Street, Madison, WI 53703, and the name of the registered agent at such address is CSC-Lawyers Incorporating Service Company.

ARTICLE VI.

The number of directors constituting the Board of Directors of the Corporation shall be fixed in the By-Laws of the Corporation.

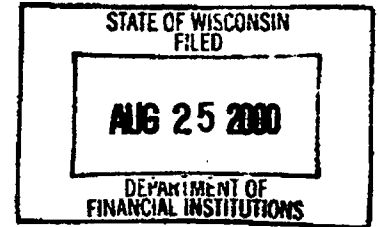
