**PARTIES**

(1) Glenaden Shirts Limited a company incorporated in Northern Ireland under No. NI038566 of Glenaden Factory, Trench Road, Londonderry, BT47 2US (Assignor), now in the administration of Moore Stephens, Donegall House, 7 Donegall Square North, Belfast, BT1 5GB

(2) BMB Clothing Limited a company incorporated in England & Wales under No. 04090249 of Granary Building, 1 Canal Wharf, Leeds, LS11 5BB (Assignee).

**1 BACKGROUND**

(A) The Assignor is the proprietor of the trade marks identified in the Schedule to this agreement (Trade Marks).

(B) The Assignor and its Administrator have agreed to assign all its rights in and to the Trade Marks to the Assignee on the terms set out below.

**2 ASSIGNMENT**

2.1 In consideration of the sum of £1.00 (one pound) paid by the Assignee to the Assignor (receipt of which is hereby acknowledged by the Assignor), the Assignor HEREBY ASSIGNS and transfers to the Assignee:

- 2.1.1 all right, title and interest of the Assignor in and to the Trade Marks
- 2.1.2 all statutory and common law, registered and unregistered rights and all goodwill of the Assignor attaching to the Trade Marks and
- 2.1.3 the right to sue for infringement and/or passing off in relation to the Trade Marks whether prior to or on or after the date of this Assignment and to recover and retain any damages and other remedies obtained as a result of such action.

**3 GOODWILL**

The Assignor confirms that this Assignment is made with all goodwill attaching to the Trade Marks

**4 ASSIGNOR COVENANTS**

- 4.1 The Assignor covenants that it:
  - 4.1.1 shall, at the request of the Assignee and at the Assignee's expense execute any further documents and do such further acts as the Assignee may require to enable the Assignee to become registered as the proprietor of the Trade Marks and/or to secure the benefits of the rights hereby assigned.
  - 4.1.2 renounces any rights which it may have in respect of the Trade Marks

## 5 INFRINGEMENT

- 5.1 Pending the recordal of the Assignee as proprietor of the Trade Marks the Assignor will lend its name to any proceedings for infringement, including but not limited to Trade Mark infringement and passing off, which the Assignee may require to be brought against any person wrongfully using the Trade Marks.
- 5.2 The Assignee shall indemnify the Assignor in respect of any costs or other liability arising out of such proceedings.

## 6 WARRANTIES




The Assignor warrants that as at the date of this Assignment:



- 6.1 the trade mark registrations are in force and all necessary fees have been paid
- 6.2 it has not granted any licence or assigned any rights of any nature in the Trade Marks to any third party in any part of the world

## 7 JURISDICTION

This Assignment shall be governed by and construed in accordance with the laws of England and the parties submit to the exclusive jurisdiction of the English courts.


