**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (“Release”) is made as of December 2, 2008, by JPMorgan Chase Bank, N.A. (formerly The Chase Manhattan Bank) (“Secured Party”), in favor of Muro Pharmaceuticals, Inc. (“Company”).

WITNESSETH:

WHEREAS, Company executed that certain Loan and Security Agreement, dated as of December 30, 1996 (“Security Agreement”), pursuant to which Company granted a security interest to Secured Party in, among other things, certain intellectual property owned by Company; and,

Secured Party hereby reconveys without recourse or warranty, all Secured Party’s right, title, claim and interest in and to the Released Collateral, all proceeds thereof, all rights corresponding thereto including but not limited to all renewals, and extensions thereof, and the recordings and applications therefor.
