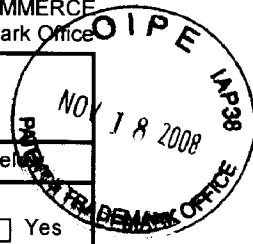


FULL RELEASE OF COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT


