**PARTIAL RELEASE**

For consideration paid, Wells Fargo Bank, National Association (successor to Wells Fargo Business Credit, Inc.) Except as specifically released hereby, the Trademark Security Agreement remains in full force and effect with respect to the remaining trademark registrations and applications listed in the Schedule A to the Trademark Security Agreement.

Reference is made to the above-described Trademark Security Agreement and the recordation thereof for all purposes in connection herewith.
