TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made as of the 27th day of November, 2008 by and between CityCenter Land, LLC, a Nevada limited liability company located at 3950 Las Vegas Boulevard South, Las Vegas, Nevada 89119 ("Assignor") on the one hand, and The Harmon Hotel, LLC a Nevada limited liability company located at 6276 S. WHEREAS, Assignee is a successor to the portion of Assignor's business to which the Trademarks pertain and is acquiring a portion of Assignor's interests in the Trademarks from Assignor;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby sells, transfers, conveys, and assigns to Assignee fifty percent (50%) of its right, title, and interest in and to the Trademarks, together with the goodwill symbolized thereby and rights to sue and recover for past infringement, if any.


Assignor agrees to execute all documents and assist in all proceedings (at the sole cost and expense of the Assignee) to perfect, register, or record the rights of the Assignee to the Trademarks as Assignee may reasonably deem appropriate. If Assignor does not, within fifteen (15) days of presentment, return the requested executed documents, then Assignee is hereby granted a limited power of attorney to execute all such documents on behalf of Assignor. This power of attorney is coupled with an interest and is irrevocable.

The parties agree and acknowledge that the United States Patent & Trademark Office records should reflect that the following two entities are now co-owners of the Trademarks:

- 1) The Harmon Hotel, LLC a Nevada limited liability company
- 2) CityCenter Land, LLC, a Nevada limited liability company


