We refer to the Revolving Credit and Term Loan Agreement dated as of December 14, 1994 (as amended, the "Loan Agreement") among Bayport Restaurant Group, Inc. and its Subsidiaries as Borrowers, The First National Bank of Boston ("Bank of Boston") and Capital Bank as Lenders, and Bank of Boston as Agent for the Lenders, pursuant to which Bank of Boston, as Agent on behalf of the Lenders, holds a lien and security interest on certain property of the Borrowers (the "Collateral").


We hereby advise you that the aggregate amount of the Borrowers' outstanding obligations to the Lenders as of the close of business on August 5, 1996 (the "Obligations"), will equal \$16,061,808.83 (representing \$15,998,486.09 in respect of principal, \$34,996.68 in respect of interest, \$.03 in respect of commitment fees, and \$28,326.03 in respect of unpaid legal fees). Funds received after 1:00 p.m. will accrue interest at a per diem amount of \$3,888.52.
