ASSIGNMENT OF TRADEMARKS

KNOW ALL MEN BY THESE PRESENTS, that House of Herbs, Inc., a business corporation duly organized and existing under the laws of the State of New Jersey ("Seller"), having its principal place of business at 38 Ann Street, Passaic, NJ 07055, in consideration of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, does hereby grant, bargain, sell, transfer, convey, assign and deliver to Woeber Mustard Manufacturing Company, a business corporation duly organized and existing under the laws of the State of Ohio ("Purchaser"), all rights, title and interest in and to the mark for the words "Mr. Mustard" (the "First Mark") and the mark for the words "Mr. Mustard" with a logo (the "Second Mark"), together with the goodwill symbolized by the First Mark and the Second Mark.

Seller's application to register the First Mark was filed with the United States Patent and Trademark Office ("USPTO") on June 24, 1947 under serial number 71524696. The application to register the First Mark was granted to Seller by the USPTO on May 24, 1949 under registration number 442744. The registration was renewed on May 24, 1969 and on May 24, 1989.

Seller's application to register the Second Mark was filed with the United States Patent and Trademark Office ("USPTO") on January 30, 1963 under serial number 72161697. The application to register the Second Mark was granted to Seller by the USPTO on October 22, 1963 under registration number 758944. The registration was renewed on December 20, 1983 and on December 29, 2003.

Seller hereby covenants to and with Purchaser that Seller (1) has good and marketable title to the First Mark and the Second Mark, subject to no liens, claims, encumbrances or restrictions of any kind, (2) has the right, power and authority to, and (3) hereby does, sell, transfer, assign and convey the First Mark and the Second Mark free and clear of all liens, claims, encumbrances and restrictions. Seller hereby covenants that it will warrant and defend the same against all lawful claims whatsoever.
