INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (“Agreement”) made as of November 5, 2008, (the “Effective Date”) among Sunrise Medical HHG Inc., a California corporation (“Assignor”) and Medline Industries, Inc., an Illinois corporation (the “Assignee”).

Unless otherwise expressly defined herein, capitalized terms used in this Agreement shall have the meanings specified in the Asset Purchase Agreement (as defined herein).

WHEREAS, subject to the terms and conditions of that Amended and Restated Asset Purchase Agreement (as amended from time to time, the “Asset Purchase Agreement”), dated as of November 5, 2008, among the Assignor, the Assignee and the other parties therein, the Assignor has agreed to sell and transfer, and the Assignee has agreed to purchase and assume, the Purchased Assets, including without limitation the Intellectual Property set forth on Schedule 1.1(f) of the Asset Purchase Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignment of Assets. On the terms and subject to the conditions of the Asset Purchase Agreement, the Assignor hereby sells, conveys, transfers, assigns, and delivers to the Assignee all of its right, title and interest in and to the Intellectual Property listed on Schedule A hereto, including Assignor’s common law rights together with the goodwill of the business appertaining to and/or symbolized by the trademarks listed on Schedule A hereto, and the Assignee does hereby accept all of the right, title and interest of the Assignor in and to such Intellectual Property.

2. Excluded Assets. This Agreement does not sell, convey, transfer or assign to Assignee any right, title or interest of the Assignor in and to any of the Excluded Assets.

3. Governing Law. This Agreement shall be construed, interpreted and the rights of the parties determined in accordance with the laws of the state of Delaware applicable to contracts made and to be performed therein.

4. Assignment. Neither this Agreement nor any of the rights or obligations hereunder may be assigned by any party (by Contract, operation of Law or otherwise) without the prior written consent of the other party. Subject to the foregoing, this Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns, and no other person shall have any right, remedy, benefit, liability or obligation under this Agreement as a third party beneficiary or otherwise.

5. Relationship to the Asset Purchase Agreement. This Agreement is intended to evidence the consummation of certain transactions contemplated by the Asset Purchase Agreement. This Agreement is made without representation or warranty, except as and to the extent provided in the Asset Purchase Agreement. In the event of any conflict or other


difference between the Asset Purchase Agreement and this Agreement, the provisions of the Asset Purchase Agreement shall control.

6. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument, binding upon the parties hereto.
