**INTELLECTUAL PROPERTY ASSIGNMENT**

This **INTELLECTUAL PROPERTY ASSIGNMENT** (this "Assignment"), dated as of April 30, 2008, is made by and between TAP Pharmaceutical Products Inc., a close corporation incorporated in Delaware ("TAP" or "Assignor"), and Lake Products Inc., a Delaware corporation ("Newco" or "Assignee"). This Assignment is being executed and delivered pursuant to, and is subject to the terms of, the Contribution and Exchange Agreement, dated as of March 19, 2008 and amended and restated as of April 30, 2008, by and among TAP, Newco, Takeda America Holdings, Inc., a New York corporation, Abbott Laboratories, an Illinois corporation, Takeda Pharmaceutical Company Limited, a Japanese corporation, and Takeda Pharmaceuticals LLC, a Delaware limited liability company (the "CEA"). All capitalized terms used and not otherwise defined herein have the respective meanings ascribed to such terms in the CEA.

**WHEREAS**, pursuant to the CEA, TAP will contribute to Newco certain assets related primarily to the Split-off Business, and certain other assets, and Newco will assume the liabilities of TAP relating primarily to the Split-off Business and certain other liabilities (as more fully provided in the CEA, the "Contribution and Assumption").

**WHEREAS**, pursuant to the CEA and in connection with the Contribution and Assumption, Assignor and Assignee have agreed to enter into this Assignment for Assignor to assign and transfer to Assignee all right, title, and interest in, to and under all Identifiable Intellectual Property that is owned by Assignor and (i) that is used primarily or held for use primarily in, (ii) that is developed primarily for, or (iii) that relates primarily to the Split-off Business, the Split-off Products or the other Transferred Assets, including, but not limited to, the Identifiable Intellectual Property listed on Schedule A hereto (the "Assigned IP").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, TAP and Newco (hereinafter referred to, at times, collectively as the "Parties" and each, individually as a "Party") hereby agree as follows:

1. Conveyance. Pursuant to Section 2.03(a)(iv) of the CEA, effective as of 11:59PM, Central Time, on April 30, 2008, Assignor hereby irrevocably and unconditionally conveys, assigns, grants, transfers and delivers to Newco, and Newco hereby accepts, all of the right, title and interest of TAP in, to and under the Assigned IP, including but not limited to (i) all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringement, dilution, unfair competition, or other violation of the Assigned IP; (ii) all income, royalties, damages and payments now or hereafter due or payable with respect to the Assigned IP; and (iii) all rights corresponding to the Assigned IP throughout the world, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives.

2. Recordation. Assignor hereby requests the Commissioner of Patents and Trademarks, the U.S. Patent Office, the U.S. Trademark Office and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the patents, trademarks, copyrights, or other Assigned IP (as applicable), and to issue any and all patents, trademarks, copyrights or other Assigned IP (as applicable) to Assignee, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee and its successors, assigns or other legal representatives. Assignee shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Assigned IP.

3. Further Assurances. From time to time after the date hereof, and without any further consideration, Assignor agrees to cause to be performed such lawful acts, and to execute such further assignments and other lawful documents, as Assignee may reasonably request to perfect or record Assignee's right, title and interest in and to the Assigned IP, and to carry out and fulfill the purposes and intent of this Assignment, including, but not limited to, identifying any Identifiable Intellectual Property that is included in the Assigned IP but not listed on Schedule A and executing all documents necessary to record in the name of Assignee the assignment of any of the Assigned IP with the Commissioner of Patents and Trademarks, and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar) promptly following identification of any such Assigned IP.

4. No Modification. Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of the Assignor and Assignee under the CEA. Notwithstanding anything to the contrary contained in this Assignment, in the event of any conflict between the terms of this Assignment and the terms of the CEA, the terms of the CEA shall govern.

5. Successors and Assigns. This Assignment shall be binding upon and inure solely to the benefit of each of the Parties and their respective successors and assigns, and nothing in this Assignment, express or implied, is intended to or shall confer upon any other Person any rights, interests, benefits or remedies of any nature whatsoever under or by reason of this Assignment.

6. Counterparts. This Assignment may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures were upon the same instrument. This Assignment shall become binding when each Party shall have received a counterpart of this Assignment signed by the other Party.

7. Section Headings. The section headings contained in this Assignment are inserted for reference purposes only and shall not affect in any way the meaning or interpretation of this Assignment.

8. Governing Law. This Assignment shall be governed by, and all disputes arising out of or in connection with this Assignment shall be resolved in accordance with, the Law of the State of Delaware (without regard to the conflicts of law rules of such state that would mandate the application of the laws of another jurisdiction).

9. Disputes. Any and all disputes arising out of or relating to this Assignment shall be governed by Section 15.05 of the CEA.

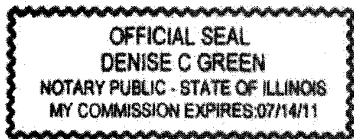
