TRADEMARK ASSIGNMENT

WHEREAS, Sunscape Eyewear Inc. Assignor shall take all such further lawful actions and sign all such further documents, and provide all such materials as may be necessary or reasonably requested by Assignee to carry out the purposes of this Assignment, including providing Assignee, at Assignee's expense, with all reasonable assistance in the event that Assignee may find it necessary to prove that the Mark has been used continuously in trade or commerce.
