## PARTIAL RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Partial Release"), dated as of December 26, 2008, is made by BANK OF AMERICA, N.A., as successor by merger to LaSalle Business Credit, LLC, as agent ("Agent"), under the Loan and Security Agreement referred to below (capitalized terms used in this Partial Release and not herein defined shall have the meanings set forth in the Loan and Security Agreement).

WHEREAS, Coachmen Industries, Inc., an Indiana corporation, Coachmen Recreational Vehicle Company, LLC, an Indiana limited liability company, and Viking Recreational Vehicles, LLC, a Michigan limited liability company (collectively, the "Grantors"), are parties to that certain Loan and Security Agreement, dated as of August 2, 2006 (the "Loan and Security Agreement"), by and among the Grantors and their affiliates, Agent and the various financial institutions party thereto as lenders;

WHEREAS, in connection with the Loan and Security Agreement, and pursuant to that certain Patent and Trademark Security Agreement (the "Patent and Trademark Security Agreement"), dated as of August 2, 2006, Grantors granted security interests in certain Patent Collateral and Trademark Collateral (as such terms are defined in the Patent and Trademark Security Agreement), including, without limitation, the intellectual property listed on Annex I attached hereto (the Patent Collateral and Trademark Collateral set forth on Annex I attached hereto are referred to as the "Released Patents and Trademarks"); and

WHEREAS, the Patent and Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on August 11, 2006 at Reel/Frame No. 018109/0114 and at Reel/Frame No. 3369/0360;

WHEREAS, pursuant to the Loan and Security Agreement, upon the sale or other transfer of assets by Grantors that is expressly permitted under the Loan and Security Agreement, the security interest in such assets shall be automatically released; and


WHEREAS, Grantors wish to confirm the release of any and all interest Agent may have in the Released Patents and Trademarks for the purpose of Grantors selling and assigning such Released Patents and Trademarks and for recording such release with the U.S. Patent and Trademark Office.
