SHORT FORM TRADEMARK SECURITY AGREEMENT

This SHORT FORM TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of December 24, 2008 is made by COPPER MOUNTAIN, INC., a Delaware corporation, FISHERMAN'S VILLAGE ONE DEVELOPMENT COMPANY, L.L.C., a Delaware limited liability company, INSPIRATION AT SANDESTIN DEVELOPMENT COMPANY, LLC, a Delaware limited liability company, INTRAWEST CALIFORNIA HOLDINGS, INC., a California corporation, INTRAWEST RESORT OWNERSHIP U.S. CORPORATION, a Delaware corporation, INTRAWEST RETAIL GROUP, INC., a Colorado corporation, INTRAWEST SANDESTIN COMPANY, L.L.C., a Delaware limited liability company, INTRAWEST ULC, an unlimited liability company incorporated under the laws of the Province of Alberta, Canada, a Delaware corporation, IW/WP FOUR-FIVE DEVELOPMENT COMPANY, LLC, a Delaware limited liability company, IW/WP VILLAGE CORE DEVELOPMENT COMPANY, LLC, a Delaware limited liability company, MOUNTAIN CREEK RESORT, INC., a New Jersey corporation, PROJECT SIERRA HOUSING TWO DEVELOPMENT COMPANY, LLC, a Delaware limited liability company, SNOWSHOE MOUNTAIN, INC., a West Virginia corporation, SP MONTELAGO DEVELOPMENT COMPANY, LLC, a Delaware limited liability company, STEAMBOAT SKI & RESORT CORPORATION, a Delaware corporation, and THE STRATTON CORPORATION, a Vermont corporation (each, individually, an "IP Grantor", or all, collectively, the "IP Grantors"), in favor of JPMORGAN CHASE BANK, N.A., located at 1111 Fannin Street, 10th Floor, Houston, TX 77002, as Administrative Agent (the "Administrative Agent"), for the benefit of the Secured Parties to that certain Amended and Restated Credit Agreement dated as of February 28, 2007 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among the Borrowers, the banks and other financial institutions from time to time parties to the Credit Agreement as Lenders (the "Lenders"), the Administrative Agent and others.

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally made extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Credit Agreement, the Grantors have all entered into that certain Second Amended and Restated Collateral Agreement, dated as of December 24, 2008 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), in favor of the Administrative Agent; and

WHEREAS, pursuant to the Collateral Agreement, each IP Grantor is granting to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in certain Collateral, including each of the following that is owned by each IP Grantor: (i) all trademarks, trade names, trade styles, service marks, logos and other source identifiers, and all goodwill associated therewith, all registrations thereof, and all applications for registration

therefor, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to in Schedule A, and (ii) the right to obtain all renewals thereof (collectively, the "Trademarks");

NOW, THEREFORE, in consideration of the premises and to induce the Lenders to make their respective extensions of credit to the Borrowers under the Credit Agreement, each IP Grantor hereby agrees with the Administrative Agent, for the benefit of the Secured Parties, as follows:

SECTION 1. Definitions. Capitalized terms used but not defined herein shall have the meanings given to them in the Credit Agreement or the Collateral Agreement, as applicable, except the terms "Secured Parties" and "Collateral" are defined as in the Collateral Agreement only.

SECTION 2. Addresses of IP Grantors. The business addresses of the IP Grantors are listed on Schedule 3 to the Collateral Agreement, which Schedule 3 is incorporated in and attached to this Agreement as Schedule B.

SECTION 3. Grant of Security Interest. Each IP Grantor hereby assigns and transfers to the Administrative Agent, and hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademarks now owned or at any time hereafter acquired by such IP Grantor or in which each IP Grantor now has or at any time in the future may acquire any right, title or interest (including, without limitation, those Trademarks listed on Schedule A hereto) as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the IP Grantor's Obligations; provided, however that the Trademarks do not include any applications for Trademarks filed in the United States Patent and Trademark Office on the basis of an IP Grantor's intent to use such mark pursuant to 15 USC 1051 Section 1(b) and for which a form evidencing use of the Trademark in interstate commerce has not been filed with the United States Patent and Trademark Office pursuant to 15 USC 1060 (a), to the extent and only for the duration that the security interest granted in such intent-to-use applications will invalidate, terminate, or abandon such intent-to-use applications under applicable law.

SECTION 4. Purpose. This Agreement has been executed and delivered by each IP Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office.

SECTION 5. Authorization to Supplement. Each IP Grantor hereby authorizes the Administrative Agent to unilaterally modify this Agreement by amending Schedule A to include any future Trademarks owned by such IP Grantor which are the subject of registrations or applications, for purposes of recording this Agreement against such newly-acquired Trademarks. Notwithstanding the foregoing, no failure to so modify this Agreement by amending Schedule A shall in any way affect, invalidate or detract from the Administrative Agent's, or the other Secured Parties', continuing security interest in all Trademarks owned by the IP Grantors, whether or not listed on Schedule A.


SECTION 6. Acknowledgment. Each IP Grantor does hereby acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks are more fully set forth in the Collateral Agreement, the terms and conditions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Agreement is deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall control.

SECTION 7. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

SECTION 8. Counterparts. This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts (including by telecopy), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
