PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

WHEREAS, said Security Agreement was recorded in the United States Patent & Trademark Office on September 19, 2002 at Reel 2584/Frame 0829;

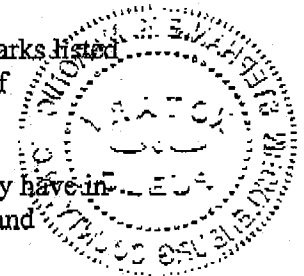
