## RELEASE OF SECURITY INTEREST IN TRADEMARKS

TO: Westwood Insurance Agency ("Grantor")

WHEREAS, pursuant to a Credit Agreement (as the same may be amended, restated, supplemented or otherwise modified from time to time), dated as of December 21, 2005, among ZC Sterling Corporation, the Lenders party thereto, and ING Capital LLC as administrative agent ("**Administrative Agent**") for the benefit of the Lenders, the Lenders severally agreed to maintain loans to the Borrower, upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantor and the Administrative Agent entered into a Trademark Security Agreement dated October 14, 2008 (the "**Short Form Trademark Security Agreement**") pursuant to a Pledge and Security Agreement, dated December 21, 2005 between the Grantor and the Administrative Agent (the "**Pledge and Security Agreement**");

WHEREAS, pursuant to the Pledge and Security Agreement and the Short Form Trademark Security Agreement (recorded in the United States Patent and Trademark Office on October 9, 2008 at Reel 3868/Frame 0024), as collateral security for the full, prompt, and complete payment and performance when due of the Obligations, the Grantor granted the Administrative Agent a lien on and security interest in all right, title and interest of the Grantor in, to and under the Trademark Collateral:

WHEREAS, the Obligations have been fully satisfied, and the Grantor has requested that the Administrative Agent release its security interest in the Trademark Collateral granted pursuant to the Pledge and Security Agreement and Short Form Trademark Security Agreement, including those on Schedule I hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in accordance with the terms and obligations set forth in the above-referenced agreements, the Administrative Agent hereby releases and discharges its lien on and security interest in the Trademark Collateral granted to the Administrative Agent.

This Release of Security Interest in Trademarks and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York. Unless otherwise defined herein, capitalized terms used herein shall have the meanings given to them in the agreements referenced above.

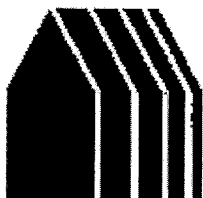


