## LICENSE DECLARATION

The undersigned:

**DELB B.V. ( formerly known as DISTILLEERDERIJEN ERVEN LUCAS BOLS B.V.)**, a limited liability company incorporated under the laws of the Netherlands having its registered offices in (2723 RB) Zoetermeer at Wattstraat 61, the Netherlands ("**DELB**");

and

**LUCAS BOLS B.V.**, a limited liability company incorporated under the laws of the Netherlands having its registered offices in (1071 CZ) Amsterdam at Paulus Potterstraat 14, the Netherlands ("**Lucas Bols**").

### WHEREAS:

- (i) Pursuant to the Hire Purchase Agreement concluded between Rémy Cointreau S.A., DELB and Lucas Bols and dated 11 April 2006 (the "**Hire Purchase Agreement**"), Lucas Bols has been granted (amongst others) a license to certain trade mark rights which are currently owned by DELB;
- (ii) Parties, for convenience sake and for registration of the license which has been granted by DELB to Lucas Bols with certain registers, wish to use this document to evidence the license which has been granted by DELB to Lucas Bols pursuant to the Hire Purchase Agreement.

### IT IS AGREED AS FOLLOWS:

#### **Clause 1 License declaration**

- 1.1 DELB and Lucas Bols have concluded the Hire Purchase Agreement pursuant to which (amongst others) the trademarks in **Annex I** to this Agreement (hereinafter the "**Trademarks**") are sold to Lucas Bols by DELB. The transfer of the legal title to the Trademarks to Lucas Bols is however under the condition precedent of payment in full of all hire purchase instalments (as meant in the Hire Purchase Agreement) by Lucas Bols over a period of ten years. During the ten year period before full and complete payment is made by Lucas Bols, DELB remains the legal owner of the Trademarks.
- 1.2 In connection with the transaction described in Clause 1.1, DELB has granted Lucas Bols a world wide (subject however to Clause 1.3), non-transferable, non-assignable and

exclusive license (with the right to sub-license) to the Trademarks as long as the transfer as referred to in Clause 1.1 has not yet taken place (hereinafter: the "License").

- 1.3 The License is subject to a previous exclusive license that was granted by DELB to Central European Distribution Corporation and Carey Agri International Poland Sp. z o.o. for Poland and Russia (and any countries that formally become a part of these two countries in the future) in so far as this concerns Trademarks which include the words "BOLS" and "VODKA" or any similar words.
- 1.4 Lucas Bols has furthermore been granted the right to initiate or defend proceedings, and take any other action as may be appropriate, for infringement or alleged infringement of the Trademarks or any other claim or counterclaim brought or threatened in respect of the use or registration of the Trademarks in Lucas Bols' name and at Lucas Bols' costs. In case Lucas Bols, in DELB's reasonable determination, is not taking adequate steps to protect the Trademarks, DELB has the right to initiate or join proceedings.

**Clause 2 Term**

- 2.1 The License has been granted as of 11 April 2006 ("**Start Date**").
- 2.2 The License shall commence from the Start Date and shall continue to remain in force and effect until Lucas Bols has fulfilled all of its payment obligations under the Hire Purchase Agreement (which is expected to take place ten years after the Start Date), unless terminated earlier.

**Clause 3 Miscellaneous**

- 3.1 In case there is a conflict between the Hire Purchase Agreement and this License Declaration, the Hire Purchase Agreement prevails.
- 3.2 DELB herewith consents to Lucas Bols registering the License in the relevant registers naming only Lucas Bols as the licensee.


**Clause 4 Dispute Resolution**

- 4.1 The provisions of this declaration are governed by, and shall be construed in accordance with, the laws of the Netherlands.
- 4.2 Any disputes arising out of or in connection with this declaration, and any suit, action or proceedings arising there from or in connection therewith, shall be brought for and settled by the competent court of Amsterdam, the Netherlands.
