CONFIRMATORY ASSIGNMENT OF TRADEMARK

THIS CONFIRMATORY ASSIGNMENT OF TRADEMARK (the "Assignment") dated as of March 14, 2008, (the "Effective Date"), is from PicoSearch LLC, a Delaware limited liability company (the "Assignor"), to PicoSearch LLC, a North Carolina limited liability company (the "Assignee").

WITNESSETH:

WHEREAS, in connection with an Intellectual Property Assignment Agreement dated March 14, 2008 (the "Agreement"), Assignor assigned to Assignee all right, title and interest in and to the trademark and the related United States registration for PICOSEARCH, Registration No. 2,323,527 (the "Mark"), together with the goodwill of the business, and all common law rights associated therewith; and

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Mark and the goodwill of the business associated therewith to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor agrees and confirms that, pursuant to the Agreement, Assignor assigned and transferred to Assignee the full, exclusive and entire right, title and interest in the Mark, together with: (1) the goodwill symbolized by the Mark; (2) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Mark; and (3) any royalties or other consideration owed in connection with use of the Mark after March 14, 2008. To the extent such assignment is or was ineffective to transfer the foregoing rights, Assignor agrees to assign, and hereby assigns to Assignee, effective as of March 14, 2008, the Mark, together with the foregoing rights.

2. Assignor further agrees, without further consideration, to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Mark, goodwill and all other rights hereby conveyed.

3. Subject to the terms and conditions hereof, Assignee accepts such assignment of the Mark and goodwill.
