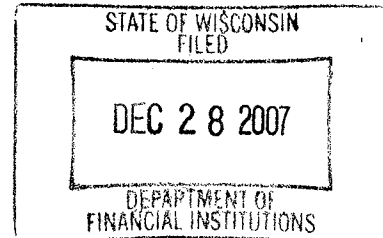


SEVENTH: None of the constituent corporations being merged into Metso Minerals Industries, Inc. has a fee simple ownership interest in any Wisconsin real estate.

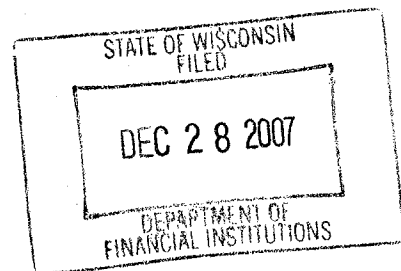
