1. The name of the corporation (the "Corporation") is Klinger Advanced Aesthetics, Inc.

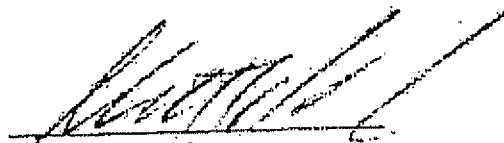
2. The Certificate of Incorporation of the Corporation is hereby amended by deleting Article I in its entirety and replacing it with the following:
