NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns unto Assignee all of Assignor's rights, title, and interest in and to the Marks, together with any applications and registrations therefore and the goodwill of the business in connection with which each of the Marks is used and which is symbolized by each of the Marks, throughout the world, along with the right to recover for damages and profits for any infringements thereof, past, present or future, and Assignor agrees not to assert any claim or cause of action against Assignee arising out of or related to Assignee's use of the Marks pursuant to this Assignment.

Assignor hereby represents and warrants that it has not sold, granted, conveyed or assigned any of the rights, title or interest it may have in or to the Marks, and that to the best of its knowledge, with this assignment, Assignee is the only entity with any rights in and to the Mark.

Assignor shall execute, acknowledge and deliver to Assignee, or shall cause the execution, acknowledgment and delivery to Assignee, of such further instruments as Assignee shall deem necessary to effectuate the intent and purpose of this Agreement.

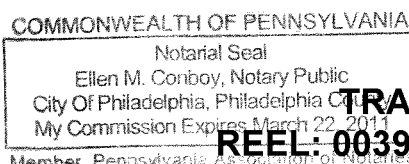
