Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and of all foreign countries to grant registrations

on the trademark **EXTENDTIME** to Assignee, its successors and assigns, as the assignee of the entire interest in the aforesaid registrations.

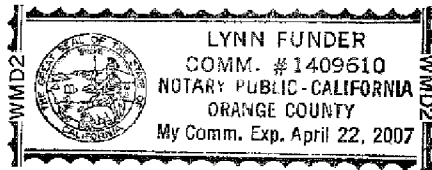
