NOW, THEREFORE, in consideration of payment of the sum of one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Rocket U.S.A., Inc. does hereby assign unto Twentieth Century Fox Film Corporation all rights, title and interest in and to said Mark, together with the goodwill of the business symbolized by said Mark, the above-identified registration for the Mark, and all rights of action and claims for past infringements thereof.

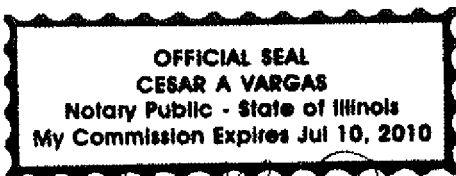
