## TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the parties hereto intending to be legally bound, said Bachem, Inc. does hereby sell, assign, transfer and set over unto said Bachem AG, all rights, title and interest in and to the Marks, together with the good will of the business symbolized by the Marks, as well as U.S. Trademark Registration No. 1,664,117 for BACHEM, and U.S. Trademark Registration No. 1,497,324 for "B" (stylized letter), and the right to recover damages and/or profits which have arisen from infringement of the Marks, the Marks to be held and enjoyed by Bachem AG for its own use and behoof, and to inure to the benefit of its successors and assigns, for the full extent and terms of any and all trademark registrations therefor, and any renewals thereof, and thereafter, as fully and entirely as the same would have been held and enjoyed by Bachem, Inc. as if this assignment and sale not been made.

And it is further covenanted and agreed by and on behalf of Bachem, Inc. its successors and assigns, that it will at any time, upon request, execute and deliver any

and all papers, consents or declarations that may be necessary or desired to carry the full intentions for the foregoing assignment into effect.
