ASSIGNMENT AND ASSUMPTION

Reference is made to the Guarantee and Collateral Agreement, dated as of May 4, 2007, (as reaffirmed by the Reaffirmation Agreement, dated as of May 25, 2007, among Bucyrus International, Inc. and the Subsidiary Guarantors signatory thereto, and as further amended, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"); the Intellectual Property Security Agreement, dated as of May 4, 2007, among the signatories thereto (collectively, and with DBT as defined below, the "Grantors"), and Lehman Commercial Paper Inc., as Administrative Agent ("Lehman"); and the Intellectual Property Security Agreement, dated as of June 29, 2007, among DBT America, Inc. ("DBT") and Lehman (collectively, the "Intellectual Property Security Agreements"). Unless otherwise defined herein, terms defined in the Guarantee and Collateral Agreement and used herein shall have the meanings given to them in the Guarantee and Collateral Agreement.

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated as of May 4, 2007, recorded with the U.S. Patent and Trademark Office on May 8, 2007, at Reel/Frame No. 019260/0457, and the Intellectual Property Security Agreement, dated as of June 29, 2007, recorded with the U.S. Patent and Trademark Office on July 11, 2007, at Reel/Frame No. 019541/0048, the Grantors granted the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its Intellectual Property, including the Patents and proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Intellectual Property Security Agreement, dated as of May 4, 2007, recorded with the U.S. Patent and Trademark Office on May 8, 2007, at Reel/Frame No. 003537/0693, and the Intellectual Property Security Agreement, dated as of June 29, 2007, recorded with the U.S. Patent and Trademark Office on July 11, 2007, at Reel/Frame No. 0003578/0001, and on June 17, 2007, at Reel/Frame No. 003582/0189, the Grantors granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its Intellectual Property, including the Trademarks, including all goodwill associated with such trademarks, and proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Intellectual Property Security Agreement recorded with the U.S. Copyright Office on July 12, 2007, at Volume/Document No. 3552/858, Grantor granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of its Intellectual Property, including the Copyrights and proceeds of any and all of the foregoing;

Lehman hereby irrevocably assigns to JPMorgan Chase Bank, N.A. ("JPM") without recourse, and JPM hereby assumes from Lehman, the interest in and to Lehman's rights and obligations under the Intellectual Property Security Agreements (the "Assigned Interest"), as of the Effective Date (as defined below).

The effective date of this Assignment and Assumption shall be the date of execution by all parties (the "Effective Date"). Following the execution of this Assignment and

Assumption, it will be delivered to JPM for recording by JPM pursuant to the Guarantee and Collateral Agreement and the Intellectual Property Security Agreements with the United States Patent and Trademark Office and the United States Copyright Office.

From and after the Effective Date, (a) JPM shall be a party to the Guarantee and Collateral Agreement and the Intellectual Property Security Agreements and, to the extent provided in this Assignment and Assumption, have the rights and obligations of the Administrative Agent thereunder and under the other Loan Documents and shall be bound by the provisions thereof and (b) Lehman shall, to the extent provided in this Assignment and Assumption, relinquish its rights and be released from its obligations under the Guarantee and Collateral Agreement and the Intellectual Property Security Agreements.

This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.

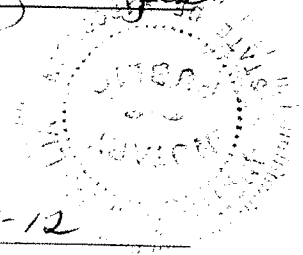


