**DEED OF ASSIGNMENT OF TRADE MARKS**

**THIS DEED OF ASSIGNMENT** is made the 18th day of November 2008

**BY AND BETWEEN**

- (1) **PCCW-HKT DataCom Services Limited**, a limited liability company incorporated in Hong Kong with its registered office at 39th Floor, PCCW Tower, TaiKoo Place, 979 King's Road, Quarry Bay, Hong Kong ("**Assignor**"); and
- (2) **PCCW Enterprises Limited**, a limited liability company incorporated in Hong Kong with its registered office at 39th Floor, PCCW Tower, TaiKoo Place, 979 King's Road, Quarry Bay, Hong Kong ("**Assignee**").

**WHEREAS**

- A. The Assignor is the proprietor of the trade mark applications and registrations details of which are set out in Schedule I and Schedule II. The trade marks set out in Schedule I and Schedule II are separately and collectively referred as "**the Trade Marks**".
- B. Assignor has agreed with Assignee to sell, assign and transfer to Assignee all rights in and to the Trade Marks subject to this Deed of Assignment.

**NOW THIS DEED OF ASSIGNMENT WITNESSES** as follows:

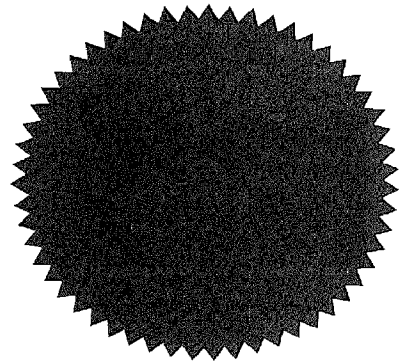
1. In pursuance of this Deed of Assignment and in consideration of these mutual promises, the Assignor as beneficial owner assigns and transfers to Assignee absolutely:-
  - (a) all the property, rights, title and interests in and to the Trade Marks including all common law rights, copyright and the goodwill of the business associated to the goods and services for which the Trade Marks are registered or used or are to be registered and all rights therein at common law; and
  - (b) all rights, both at law and in equity, to maintain and enforce any rights subsisting in the Trade Marks, including but not being limited to commencing and maintaining legal proceedings for passing off and/or infringements of trade marks and copyright or other similar proceedings in respect of the Trade Marks.
2. (a) Assignor hereby agrees to sign and execute any further document that Assignee may reasonably require for recording or registering the transfer of rights to enable the Assignee to become registered as the proprietor in respect of any of the Trade Marks assigned. If Assignor defaults in signing and/or executing the same, Assignor hereby irrevocably appoints Assignee or its nominee as attorney to Assignor for this purpose.
3. (a) Assignor warrants that it has the right of proprietorship in the Trade Marks and has full power to enter into this Deed of Assignment.

(b) Assignor shall, upon the request of Assignee, make any necessary application to the relevant Trade Mark Registry or Office for amendment or cancellation of any trade mark registration or application for the purpose of absolutely vesting the Trade Marks in favour of the Assignee.

4. This Deed of Assignment shall in all respects be interpreted in accordance with the laws of Hong Kong and shall be subject to the non-exclusive jurisdiction of the courts of Hong Kong.

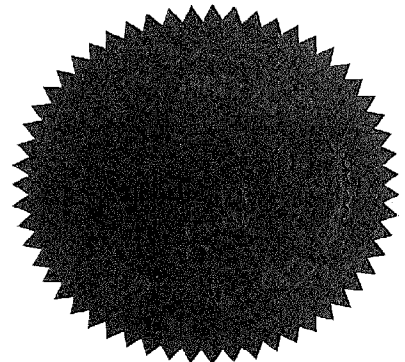
