The Assignor covenants that it will promptly execute and deliver all documents, papers, forms and authorizations which may be necessary for securing, completing or absolutely vesting the Assignor's rights, title and interest in and to the Registrations and the Marks, in favour of the Assignee.


This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
