Certificate



**FIRST AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF  
PLAY OUTDOORS, INC.**

These First Amended and Restated Articles of Incorporation amend and restate the Articles of Incorporation of Wee Outdoors, Inc.

**ARTICLE 1  
Name**

The name of the corporation is Play Outdoors, Inc. (the "Company").

**ARTICLE 2  
Authorized Shares**

The Company is authorized to issue 10,000 common shares.

**ARTICLE 3  
Purpose**

The purposes of this Corporation are to engage in any lawful activities for which corporations may be organized under Oregon Statutes as from time to time constituted; and this Corporation shall have those powers which are given to corporations under Oregon Statutes presently constituted and those powers which may hereafter and from time to time be given or permitted to corporations under Oregon law.

**ARTICLE 4  
Duration**

The duration of this Company is perpetual.

**ARTICLE 5  
Action Without Meeting**

Action required or permitted by the Oregon Business Corporation Act to be taken at a shareholders' meeting may be taken without a meeting if the action is taken by shareholders having not less than the minimum number of votes that would be necessary to take such action at a meeting at which all shareholders entitled to vote on the action were present and voted.

**ARTICLE 6  
Liability of Directors**

The personal liability of a director to the Company or its shareholders for monetary damages for conduct as a director is eliminated to the fullest extent permitted by law.

**ARTICLE 7**  
**Indemnification**

- 7.1 Indemnification.** The Company will indemnify an individual made a party to a proceeding because the individual is or was a director or officer against liability incurred in the proceeding to the fullest extent permitted by law.
- 7.2 Advance for Expenses.** The Company will pay for or reimburse the reasonable expenses incurred by a director or officer who is a party to a proceeding in advance of final disposition of the proceeding to the fullest extent permitted by law.

**ARTICLE 8**  
**Effective Date**

These First Amended and Restated Articles of Incorporation will become effective upon filing with the Oregon Secretary of State.
